Delivery

- Deliveries with clearly visible transport damage will not be accepted or will be accepted under reserve.
- Goods are to be delivered on exchangeable and undamaged Euro-pallets according to EPAL standards, stacked up to a
 maximum height of 1.1 meters and to a maximum weight of 600 kilograms. Pallets need to be properly packed and
 secured. The pallets' load should not extend beyond its dimensions.

 disposed of without consultation. Mixed pallets will be repacked onto single-article Euro pallets before acceptance.
